Update From Biblical Christian Solutions In Government

This is a platform for us to meet a portion of our goal of advocacy and education concerning Biblical principles and God's word applied to government, law, justice, administration, public policy, culture, and God's purpose in the world.

We are in need of - our Federal, State, and local governments are in need of - God's ambassadors. These ambassadors are needed in public office, displaying God's character and integrity, and moving our foundation of law back onto the cornerstone of God's word in the



Bible, and into submission to God's authority. Our very rights find there dependence on God's word. Justice finds its dependence on God's word. To be apathetic at the present time is to allow God, to allow Jesus, - the source of our freedom - to be cast aside in exchange for a pseudo-foundation of ever growing, and ravaging, cruelty - it is to choose to allow the light of God's word to be obscured and hidden from the public's general knowledge. Why is this so important? Why would it be cruelty? As Rufus King, a Founding Father and signer of the U.S. Constitution, points out:

[T]he... law established by the Creator... extends over the whole globe, is everywhere and at all times binding upon mankind.... [This] is the law of God by which he makes his way known to man and is paramount to all human control.

God has instituted Government for his purposes, and to work in coordination with his word, and he means for government to meet its highest purpose and fulfillment - so citizens can become the very goodness of God's character that people innately desire.
